Mark—Presented us a copy of the Lake County nuisance ordinance for us to review. Toni will make copies of it and give to Board Members next month

Mark—We have a new Sheriff's Deputy who serves our area and who encourages us to have neighborhood watch meetings every month or so. The new officer is Roman Buchberger.

Mark—Hudson's house is going to court for property maintenance issues. Many neighbors have complained out it.
