# Treasurer's report:

Our new liability insurance company inspected our neighborhood and proceeded to cancel our policy claiming that we managed rental properties in the neighborhood. Rachel wrote them to explain that we (PLH) do not own any houses, rentals, time-shares, or the like as an association, and that any such property is owned privately. We hope that this will clear up the issue.

# **Other Reports**:

Mark—Several neighbors were complaining about the weeds and general appearance of the lot at Forest and Highwoods, and the house at Oak and Highwoods.

Andrea—As of right now, there was not a start time for the new rip-wrap seawall at the south park.

# **Continuing business:**

- Review PLH membership directory—Judy & Board will work on this over the next several meetings.
- South park walkway repairs—Will be done in Lake Villa Township's next year's budget. Jim Jorgensen has no long-term plan for this, but he and Mark Johnson will keep an eye on it and keep it cleaned out. Will be removed from cont. business.
- Follow up with Army Corp of Engineers re: pier permits—Mark, after seawall issues are resolved.

- Move money market funds to CD-working on it with advice from tax professional.
- South Park seawall repairs—Permits paid for and work should start soon.
- Street light at Elm and Highwoods—Check with Lake Villa Township.
- Discuss additional insurance items and umbrella policy—this will be moved to annual meeting list.
- Welcome new people to neighborhood—Toni, Judy and Andrea will continue to provide welcome packets to newcomers.

#### New business:

- Jim Jorgensen will provide additional "No Parking" signs so that the sheriff may issue parking tickets as needed.
- Hire Jim Smak to trim trees and shrubs.
- Toni will put out the signs and deliver the flyers for the spring cleanup.
