Andrea—Attempting to get quotes on seawalls. Captain Rod is the only one to respond so far. He will not do a wood seawall, only rip rap and steel.

If only one person does all the calling (Board member, for instance), they become a "nuisance caller" in the eyes of the sheriff's department. Response is also based on the number of calls.
